

Suffolk Police and Crime Panel - Forward Work Plan (FWP)

- Road Safety [possibly using a Task & Finish Group approach?]
- Cybercrime [perhaps in January 2017 - possibly using a Task & Finish Group approach?]
- Sickness levels and Most Similar Group comparison (look at HMIC stats)
- Publicity and engagement of PCC / Constabulary (including perception of lack of visibility, victims feedback, etc - Maybe focus on treatment of victims?)
- Domestic Abuse
- Mental Health
- Justice System
- New policing model (engagement, SNTs)
