

Suffolk Police and Crime Panel - Forward Work Plan (FWP)

Potential areas of further interest as **possible future agenda items**, suggested at previous Panel meetings or informal workshops, are:

- Sickness levels and Most Similar Group comparison (look at HMIC stats)
- Publicity and engagement of PCC / Constabulary (including perception of lack of visibility, victims feedback, etc - Maybe focus on treatment of victims?). Schedule a review of the PCC's holding to account of the Constabulary regarding engagement with the public?
- Mental Health
- Justice System
- Update on the PCC's plans regarding the Fire Service / Blue Light integration
